The Tweedy, Browne Worldwide High Dividend Yield Value Fund seeks long-term growth of capital by investing in companies around the globe that the Adviser believes to have above-average dividend yields and reasonable valuations.

COMMITMENT OF THE ADVISER

As of March 31, 2017, the current Managing Directors and retired principals and their families, as well as employees of Tweedy, Browne, had more than \$1.1 billion in portfolios combined with or similar to client portfolios, including approximately \$7.2 million in the Worldwide High Dividend Yield Value Fund. Our Managing Directors have been with the firm for tenures ranging from 24 to 41 years. No partner in the history of Tweedy, Browne has ever left the firm except for the reason of retirement.

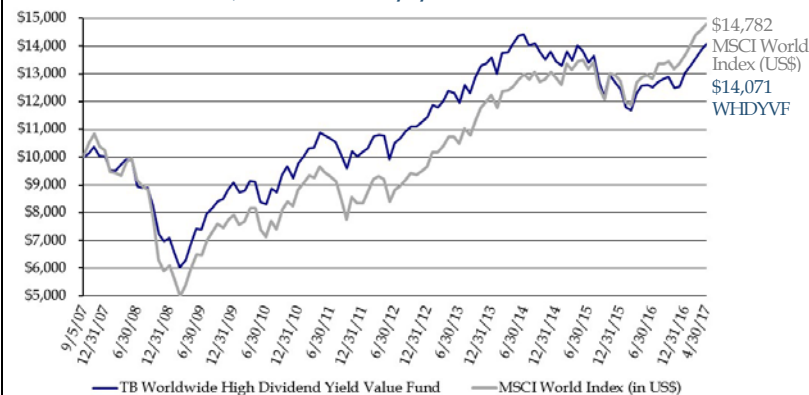
